The General Counsel works with the administration to ensure legal compliance and manage risk and provides broad oversight on all matters related to the legal and regulatory requirements under which the University operates. The General Counsel has conduct over and is accountable for all legal matters arising at the University and for protecting the University's legal corporate interests.

The General Counsel will be an engaged and proactive leader with in-depth knowledge of corporate and contract law demonstrated by the ability to draft, revise and review all contracts to which the university is a party. The General Counsel will have experience in the development and/or review of procedures, practices, and processes to limit legal exposure, supported by superior negotiation and communication skills.
